(i) I agree to an examination by my medical practitioner prior to admission for the purpose of obtaining the required Medical Report. Together with this Application, I agree to submit the required Dependency Rating sheet for assessment of care required. (In cases of potential dementia, it is required for the applicant to come for a 10 day assessment period before being accepted by Stromboli's.)

(ii) I agree to accept the care and accommodation made available by Stromboli's, to abide by all conditions and regulations set by management, and adhere to payment of monthly fees on due date.

(iii) I further agree management shall have the right to change my accommodation, within limits, as it may deem necessary or advisable, or as the exigencies of any situation may require. Should management find, however, that it cannot provide adequately for my special needs within the available facilities, it shall be entitled to arrange my transfer to another more suitable institution, which shall be at my expense.

(iv) If the service of a full time private care giver is required, all costs in this regard will be for my account.

Fee structure

1. Long Term Frailcare: Where accommodation is expected to be more than three months, a **“Bed Charge” of R10,000.00 is payable on admission.** This is a once off payment to cover the maintenance and general repair of the room and refreshing of furnishings and linen when necessary. **This is not refundable on death or departure of the occupant.**

Monthly levy: R13,000.00 - for the main 6-bed block and the Courtyard Annex, subject to annual escalation at the discretion of the Management Committee.

Monthly levy excludes Doctor's fees, medications and any other medical requirements e.g. incontinence apparel, dressings, medical waste removal, all of which will be charged separately on the monthly invoice.

2. Short Term Frailcare:

Short Term will be considered if the stay is expected to be less than 3 months. Thereafter the Long Term levy and Bed Charge will become applicable.

Short Term charges range from R 520.00 per day to R650.00 per day, dependent on the level of care required, which will be determined by the Frailcare manager.

Only the designated doctor, or his official stand-in will treat the patient. Staff will act on this doctor's instructions alone and no interference from anyone else will be allowed. Medical information regarding the patient must be obtained from the doctor concerned.

3. Garden Rooms and Rose Rooms (Assisted Rentals) - **Single room en-suite bedsitter: R2,000.00 non-refundable bed charge on admission and R8,490.00 per month, payable in advance, subject to annual escalation.**

On the death of a Frailcare or Assisted Rental resident, any outstanding balance owing is due by next of kin or guardian within 15 days. There will be no refund for the balance of the month. On voluntary departure from Frailcare or Assisted Rentals, one month's notice is required or payment of the following month's levy/rental.
